## Club Rules

D.T.M (Don't Tell Mama) aims to create a safe and enjoyable entertainment venue for members of Gay and Bi-sexual men and friends 25 and over.

D.T.M. is a Men Only venue.

Please read these terms and conditions carefully. In consideration of us allowing you to access the club, you agree to be bound by these terms and conditions.

<u>Neighbourhood</u>: Please be aware that the surrounding area is a residential zone. PLEASE AWAYS REMEMBER TO BE QUIET IN THE ENTRANCE AREA either while smoking, entering or leaving the club.

You must realise that noise outside the club might make me lose my license, my lively hood and your club.

<u>Property</u>: Members are encouraged to treat 'Don't Tell Mama' as their second home therefore respect for the property goes without saying.

Membership: You do not need to be a Member to attend D.T.M.

<u>Proof of Age Standards Scheme (PASS)</u>: All D.T.M events are over 25s and as such those who look under 25 will be challenged and must provide evidence that they are 25 and over before being allowed into the club.

The Proof of Age Standards Scheme (PASS) is the UK's national guarantee scheme for proof-of-age cards. The Club actively encourages all young people to consider a PASS card as the preferred and guaranteed form of ID.

Other acceptable forms of I.D. include a driving license or passport. All Proof of I.D. cards MUST display the PASS hologram.

Sign in on arrival: EVERY ONE has to sign in upon arrival.

Members = Full Name

Guests = Full Name + Address

At capacity there is NO FURTHER ENTRY.

Note: NO 'one in, one out'

If there is a FULL sign on the front door: DO NOT press the buzzer, DO NOT wait or queue in front of the Club, kindly make your way to a different venue quietly, if you fail to do so you might see your membership revoked and/or be barred from the Club. There will be no further entry regardless of your membership or the number of people leaving the club.

Smoking: '3 AT A TIME POLICY'

Smokers MUST ask the bar staff permission to go outside to smoke.

<u>Conduct towards other members:</u> Members are expected to enjoy the club, settle in, chat to us, and introduce yourselves, you never know which connections we can help you make.

All members must respect basic human rights and act without discrimination on grounds of gender, race, colour, language, disability, religion or politics. All members are equal, treat them that way. Treat the staff as you do members.

Anti-Social Behaviour: Anti-Social behaviour of any description on arrival, during the evening or when leaving the premises will not be tolerated. Offenders risk permanent exclusion for a first offence.

Any confrontation of any kind towards me, a member of staff or any other members will revoke your membership and you will be barred from the club.

## D.T.M actively oppose:

- any behaviour which is likely to have an adverse affect on the good name and reputation of The Club.
- . any behaviour by our members which is likely to adversely affect the health, welfare or well-being of any members.

Membership will be revoked.

You are reminded that if you were to present yourself at the door under the influence of alcohol you will be refused entry.

Should we feel you have had enough to drink during the night, we will refuse to serve you alcohol or ask you to go home.

This is for your own safety and it is the law!

I have and I am working very hard to make D.T.M. a successful, friendly and incident free venue, I will never put my license in jeopardy.

Zero Tolerance to Drugs: The Club will not tolerate the supply or use of drugs on the premises. Any offenders will be excluded immediately. and the Police will be informed.

Losses, Liabilities etc.: Neither us, our employees, will be liable to you for any loss, damage, theft of any property brought onto our premises or personal injury.

The Club shall not be liable to a Member or Guest for any loss or damage to property caused by the misconduct or negligence of a Member/Guest.

<u>Cloakroom/Lockers:</u> Members are solely responsible for their own belongings while at The Club and items that are left in cloakroom/lockers at the owner's own risk.

<u>Safety first:</u> If you were to spill your drink you <u>MUST INFORM ME or Jason at ONCE</u>. The floor parquet becomes very slippery when wet and dangerous.

<u>Security:</u> The Club reserves the right to search bags on entry to the premises for your own safety and protection.

CCTV Operating Procedures: The Club takes Members' rights to privacy very seriously. The Club employs the use of CCTV cameras and operates them within a strict Code of Practice. All CCTV Operators are thoroughly trained to operate within this Code of Practice and all relevant legislation. The system has also been fitted with 'privacy zones' to ensure that private areas cannot be looked into. The system has been registered under the Data Protection Act 1998 and operates within the guidelines laid down by the Information Commissioner. The system is operated in accordance with the Human Rights Act 1998, the Regulation of Investigatory Powers Act 2000 and the Freedom of Information Act 2000.

Images recorded by the CCTV cameras are retained for 28 days and are then wiped unless required for an ongoing investigation by an enforcement agency. No images are provided for commercial, entertainment or any other purposes.

The Club reserves the right to refuse admission without reason.

D.T.M ensures it acts in compliance with the Data Protection Act, in regards to all personal data kept of its members. We ensure your personal details will not be passed on for use by a third party.
